Scope of project:

Website Build:

1. Initial design & development will be completed on the StGeorgeDEV Servers (client link will be provided)
 - a. James from Dynamic will secure 'vtrstockton.com' and host on his servers
 - b. Initial review & revisions will be made with client prior to migration
 - c. Once the initial design is approved, website will be migrated to the client's host and launched on their URL
2. Once we receive final approval on the website design, we will migrate the website to the client's new hosting plan

Costs and Launch Date:

1. It will take roughly 3-weeks after the client has approved and retained our services
2. Estimate a launch date of late-August
 - a. This estimate is provided as a guideline - *actual delivery will depend on the actual acceptance of this proposal*
3. Cost for this project will be **\$2,350.00** and will be billed in installments (this includes a \$500.00 multi-website discount):
 - a. A retainer of \$1,850.00 less a \$500.00 multi-website discount=\$1,350.00 to start and secure our involvement on this project
 - b. The balance of \$1,000.00 will be billed prior to the website being migrated
4. An *Optional* Website maintenance service is available for a Quarterly fee of \$300.00
